Unless waived in writing by the Hillsdale Free Public Library, I agree to furnish a Certificate of Insurance specifically naming the Hillsdale Free Public Library and Borough of Hillsdale as additional insured providing general liability coverage including, bodily injury and property damage with minimum limits of liability not less than \$500,000 non-profit group organization / \$300,000 individual. In order to induce the Hillsdale Free Public Library (Borough of Hillsdale) to accept this Hold Harmless Agreement, the following information concerning the intended use of the premises is furnished:
